The BVCC Board meeting was held in-person at the Highlands Crossing Center Training Center on Monday, December 12, 2022.

Joel Ewing, Club President, called the meeting to order at 6:00 p.m. Members attending included: Woody Ogden, Vice President, Dean Larsen, Treasurer, Lori Obrenovich, Secretary, Geri Hoerner, Membership Chair, Grace Chang, Education Chair, Julie Storm, Publicity Chair, and board members Loretta Ostenso and Russ Ogden.

Old Business:

Minutes: With no corrections to the November minutes, they were approved as distributed.

Treasurer's Report: The treasurer's report for November was prepared and reported by Dean Larsen, Treasurer, noting the following: A starting balance of \$9,332.94, Income \$253.08 (which includes dues \$143.02 and donations \$102.51), expenses \$970 (including an annual \$400 insurance payment), ending balance \$8,616.02.

Membership: The membership report prepared by Geri Hoerner was reported and now totals 117.

Grant Progress: BVCC has been setup at cybergrants.com as a qualified non-profit for donations. A number of other grant/donation possibilities depend on the club's presence at cybergrants.com. This was used to set up BVCC for Wal-Mart's Round-Up program where BVCC can be a selected charity for a small donation when online purchases are made from Wal-Mart. At least twenty people will be needed to qualify for a possible additional donation from Walmart before December 25th.

Help Clinics are scheduled for December 21st and January 7th from 9:00 am to noon.

New Business:

A members' dues increase was again discussed and effective January 1, 2023, members will begin paying \$30 per year for the first member of the household and \$15 for each additional member in the same household. Members will be able to renew 30 days in advance. The increase was approved following a motion by Loretta Ostenso, a second by Lori Obrenovich and members' approval.
